#### ADVICE WORK

1.1 We continue to assist people with complaints about print and broadcast media. And about 'selling my story'. We continue to advise people that stories which are in the public interest should have no price tag.

#### 2. PROJECTS

## 2.1 Refugees, Asylum-seekers and the Media (RAM Project)

2.1.1 The Director continues to be consulted on media issues by refugees and their organisations including the City of Sanctuary movement and Bristol Hospitality Network.

#### 2.2 Health, Environment & Media

2.2.1 We continue to work with World Health Communication Associates, and have partnered WHCA in bids for health communication contracts.

#### 2.3 Diversity

- 2.3.1 The Director was commissioned by the Media Diversity Institute to produce a handbook on media relations for civil society groups in China in association with UN-ESCO.
- 2.3.2 In December 2019 the Director spoke at the Skopje launch of the MediaWise handbook 'Disability: Out in the Open' produced for rights groups in Macedonia. The event was also attended by the Macedonian Prime Minister,

#### 2.4 Children

2.4.1 The Director was commissioned by the Maharat Foundation and UNICEF to devise and deliver a workshop n Beirut for university professors designed to introduce modules on ethical media coverage of children to journalism courses in Lebanon.

#### PUBLIC AFFAIRS

- 3.1 In December 2019, at the invitation of the International Federation of Journalists, the Director spoke at a conference on media accountability in Tangier organised by the Moroccan Journalists Union.
- 3.2 The Director to act as an editorial consultant for the media team at The Bristol Cable advising on legal and ethical issues.

#### PARTNERSHIPS

### 4.1 National Institute for Social Integration (Lithuania)

- 4.1.1 The Director contributed to a series of activities as part of the Media4Change Voice4Migrants project. He curated a workshop in San Sebastian, Spain for working journalists, and contributed to events with young activists in Vilnius and Budapest, before curating the closing conference in Vilnius in the summer of 2019 4.1.2 In January 2020 the Director presented the awards at the first ever Media
- Awards ceremony organised by the National Institute for Social Integration in Vilnius, Lithuania.

#### 5.2 Management

Day-to-day management of the Trust's activities is the responsibility of the Honorary Director and Company Secretary Mike Jempson, who reports directly to the Board.

#### 5.3 Trust staff

The Trust can no longer afford full-time paid staff. We remain extremely grateful to voluntary admin services provided by Wayne Powell. The Director Mike Jempson works on a part-time basis receiving a fee for any work done on paid contracts he obtains for MediaWise.

#### 5.4 Solicitor

The Trust's honorary solicitor is Mark Stephens of Howard Kennedy FSI, No. 1 London Bridge, London SE1 9BG.

## FUNDING AND FINANCIAL MANAGEMENT

#### 6.1 Funding

- 6.1.1 The Trust is now largely funded by earnings from training courses and consultancies and occasional private donations.
- 6.1.2 No specific fund-raising applications have been made during the year.
- 6.1.3 The Trust is having to rely on the goodwill of the Director who covers the costs of storing the Media Research Library and Trust files as no suitable alternative archive has been identified.
- 6.1.4 The Trustee are most grateful for the continued services provided by our external book-keeper and accountant Selman Sheshi.

#### 6.2 Trustees' responsibilities

The Trustees are responsible for safeguarding the assets of the company and for taking reasonable steps to prevent and detect fraud and other irregularities. Our Treasurer and Book-keeper ensure that full accounting records are kept in such a way as to facilitate presentation, with reasonable accuracy at any time, of the financial position of the company and to enable the Trustees to ensure that the accounts comply with the Companies Act 1985, and with the Statement of Recommended Practice Accounting for Charities [2000].

#### 6.3 Risk Assessment

The Board has kept under constant review the major risks to which the charity is exposed and put in place arrangements to mitigate those risks. Internal risks are minimised by the implementation of procedures for authorisation of all transactions to ensure consistent quality of delivery for all operational aspects of the charitable com-

pany. The Board is acutely conscious of the fragility of the Trust's current predicament and its reliance upon the goodwill and commitment of volunteer staff.

6.4 Reserves Policy

The Trustees had established a policy that unrestricted funds not committed or invested in tangible fixed assets ('the free reserves') held by the charity should be sufficient to cover between 3 and 6 months of basic running costs. However the Trust is now operating with much reduced financial liabilities and with no contractual obligations to staff. The aim now is to keep around £500 in reserves, enough to cover storage costs for two months.

#### 6.5 Accounts

The accounts for the financial year have been prepared on the going concern basis according to established accounting policies, and give a true and fair view of the state of affairs of the charity. In preparing this financial report the Trustees have taken advantage of special exemptions applicable to small companies.

#### 6.6 Audit

Changes to accounting requirements mean that organisations with a turnover under £500,000 do not require an audit. Therefore, as MediaWise falls under this threshold, we have had an Independent Examiner's Report produced by Selman Sheshi of ERISA Accounting, 22 Stepney Walk, Bristol, BS5 9AX instead of a full audit.

#### STATUS, AIMS AND OBJECTS

- 7.1 The MediaWise Trust is a limited company (No. 3747192) and registered as a charity (No. 1076002) in 1999, having previously operated since 1992 as a voluntary organisation and then as a not-for profit company under the name PressWise.
- 7.2 The aims and objects of the Trust remain:
- A. To promote for the benefit of the public compliance with ethical standards of conduct and with the law by journalists, broadcasters and all others engaged in or responsible for the media, in the United Kingdom and elsewhere, in particular (but not exclusively) by:
- i. the provision of advice and assistance (not including individual representation except where the individual affected has insufficient means to afford legal or other specialist assistance) to members of the public concerning actual, possible or apprehended breaches of some recognised ethical standard or law;
- ii. the advancement of the education and training of the public, of media students and professionals, and of all others engaged in or responsible for the media in respect of recognised ethical standards and the law;
- iii. the education of the public and the carrying out of research (and the publication of the useful results thereof) into:
  - a) the ownership, distribution, consumption, control and influence of the media;
  - b) the legal and ethical context and effect of relevant law, guidelines, policies and codes of practice;
  - c) the methods and means available to members of the public for securing correction, redress, or remedy in relation to media coverage and journalistic activity;
  - d) the prevailing standards of the media and of media coverage and journalistic activity;

- c) the methods and means available to members of the public for securing correction, redress, or remedy in relation to media coverage and journalistic activity;
  - d) the prevailing staractivity;
- e) the actual, possible or apprehended instances of unethical, unlawful, unfair or inaccurate media coverage and journalistic activity (including instances of bias or misrepresentation) judged against recognised ethical standards and the law.
- B. To advance the education and training of the public and in particular members of charitable and non-charitable voluntary organisations in the UK and elsewhere in all forms of communication media and in particular the effective utilisation thereof.

## Independent Examiner's Report to the Trustees of The MediaWise Trust

I report on the accounts of The MediaWise Trust for the year ended 31 March 2020 which comprise the Statement of Financial Activities, the Summary Income and Expenditure Account, the Balance Sheet and the related notes.

Respective responsibilities of trustees and examiner

The charity's trustees (who are also directors of the charitable company for the purposes of company law) are responsible for the preparation of the accounts. The trustees consider that an audit is not required for this year under Section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.

Having satisfied myself that the charity is not subject to audit under company law and is eligible for independent examination, it is my responsibility to:

examine the accounts under Section 145 of the 2011 Charities Act. to follow the procedures laid down in the General Directions given by the Charity Commission (under section 145(5)(b) of the Charities Act, and to state whether particular matters have come to my attention.

## 1 Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK nad Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

#### 1.2 Income

These are included in the Statement of Financial Activities (SoFA) when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain they will receive the resources; and
- the monetary value can be measured with sufficient reliability

## 1.3 Liability recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

#### 1.4 Governance costs

Include the cost of the preparation and examination of statutory accounts, the cost of trustee meetings and the cost of any legal advice to trustees on governance or constitutional matters.

## 1.5 Grants with performance conditions

Where the charity gives a grant with conditions for its payment being a specific level of service or output to be provided, such grants are only recognised in the SoFA once the recipient of the grant has provided the specific service or output.

#### 1.6 Taxation

The Charity is a charitable institution with exemption from UK taxation under section 505 of the Income and Corporation Taxes Act 1988.

## 1.7 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following basis:

Display Equipment 25% per annum reducing balance basis

Computer Equipment 33.33 % per annum straight line basis
